



Dear Member,

Olympia Credit Union will be awarding 3 scholarships this year. One for \$1,000.00, one for \$750.00 and one for \$500.00 to be used toward our member's college education during the 2019-2020 school year.

Applicants must be an Olympia Credit Union member in good standing with Olympia Credit Union (no delinquent loans, overdrawn or charged off accounts) at the time the scholarship is given. All applicants must have been a member at Olympia Credit Union for at least 6 months at the time of the application. Applicants must attend an accredited university, college or trade school during the specified academic year, and funds must be used during the same year. Applicants must submit a transcript showing enrollment. Olympia Credit Union will control funds. The winners from the previous year are not eligible and must wait one academic year before applying.

If you would like to be considered for our scholarship this year, please fill out the attached form and follow the directions below. You may attach another sheet of paper if needed.

This application must be received by March 15, 2019 no later than 5:30 p.m. at Olympia Credit Union; 202 9<sup>th</sup> Ave SE; Olympia 98501. Winners will be notified by phone or mail no later than April 5, 2019. **Upon notification, winners must provide the credit union with instructions on how the university, college or trade school would like the Cashier's Check made out and the correct address to receive the funds.** By accepting the scholarship funds, winners agree to allow the credit union to publish their names as scholarship recipients in any format the credit union may choose, such as but not limited to, the annual newsletter or online social media.
